Mc Mullan Jun^r. his Heirs & assigns both Given Granted Bargained Sold conveyed & confirmed & by these presents both fully freely clearly & absolutely give Grant bargain sell convey & confirm unto the S^r. Alex^r. Mc Mullan Jun^r. his Heirs & assigns forever all the Sott of Land Number Twenty three fronting one hundred five feet & back Two hundred & ten agreeable to the plan of the Town laid off on the Lands purchased of William Petty by the trustees appointed by the Honourable General Assembly to lay of a Town on the Lands of Thiel Surlock out^d and all the reversion & Reversions Remain^r. over & remainders & all the whole Site Cattle & Estate of the S^r. Math Jones into or out of the S^r. Sott & premises to have & to hold forever the S^r. Alex^r. Mc Mullan Jun^r. his Heirs & assigns free & clear from all Incumbrances and claims whatsoever to his & their proper use benefit & behoof forever and the S^r. Math Jones for himself his Heirs & assigns the S^r. Sott unto him the S^r. Alex^r. Mc Mullan Jun^r. his Heirs & assigns will well & Truly warrant & defend forever Witnesses whereof the S^r.
